Article 3 – Preamble

- 3.1 Euronext operates regulated markets (the “**Platform**”) and runs a Market Maker programme governed by the Market Making Agreement (the “**Market Making Agreement**”) which is comprised of this Registration Form, the Market Making General Terms and Conditions and the Market Making Operating Terms. This Market Maker programme is for Members that agree to provide liquidity on the Platform according to certain criteria, detailed in the relevant Market Making Operating Terms.
- 3.2 Certain Financial Instruments are subject to Market Making Schemes (“**Market Making Schemes**”) under which the Relevant Euronext Market Undertaking may provide various benefits to the Market Maker. The operation of the Market Making Schemes is subject to the terms of the Market Making Agreement, including the Market Making General Terms and Conditions.
- 3.3 Capitalised terms in this Registration Form have the meanings ascribed to them in the Market Making Agreement and/or the Euronext market rules (“**Market Rules**”).
- 3.4 The Member submitting this Registration Form must be an eligible Market Maker in accordance with applicable terms and the Market Rules.
- 3.5 The Market Maker agrees that it will support the Platform by providing liquidity in a selection of Financial Instruments traded on the Platform in accordance with the Market Making Agreement, the Market Rules and applicable law and regulation. The Financial Instruments in relation to which the Market Maker wishes to engage in Market Making activity are to be identified in Appendix I. The list in Appendix I may be amended from time to time in accordance with the Market Making General Terms and Conditions.

Article 4 – Market Maker’s commitments & obligations

- 4.1 The Market Maker’s obligations in relation to its Market Making activity shall be governed by, inter-alia, the commitments described in the Euronext Market Making Operating Terms published and amended from time to time by Euronext.
- 4.2 Where order/quote injection models are used to meet the Market Maker’s obligations, the Market Maker shall ensure that such models are agreed by the Relevant Euronext Market Undertaking in advance and conform to requirements that are prescribed by the Relevant Euronext Market Undertaking from time to time. The Relevant Euronext Market Undertaking may limit the number of messages to be used by the Market Maker in cases of excessive usage in order to maintain an orderly market.
- 4.3 In accordance with the Market Making Agreement and any relevant Market Making Scheme, the Market Maker will maintain a spread of firm bid and offer prices during the continuous trading session with comparable size as detailed in the Market Making Agreement Operating Terms.

Article 5 – Termination

- 5.1 The Agreement may be terminated in accordance with the Euronext Market Making General Terms and Conditions.
